Clarifications of Rules for 2018

We have received some questions about how to read CERS rules 2018 about Combination Jumps in the Freeskating of Espoir & Cadet Categories and to apply deductions.

The rules inserted for 2018 are perfectly in line with World Skate rules for Junior and Senior for have programme in 2018 ready for the future and for Rollart.

Reading the limitation on Combination Jumps about the maximum jumps allowed, when is written cannot be more than five (5) in Cadet, or maximum five (5) - three (3) in Expoir, it's obvious like in Youth-Junior-Senior that is INCLUDING THE CONNECTING JUMPS.

Therefore the rules 132 and 133 about Combination Jumps become:

Rule 132 – Cadet Long Programme - (page 10 CERS ATC Book)

..... Omissis

- Maximum two (2) jumps combinations are allowed. The number of jumps within the combination cannot be more than five (5), including the connecting jumps.

Rule 133 – Espoir Long Programme – (page 11 CERS ATC Book) Omissis

- Maximum two (2) jumps combinations are allowed, out of which one could be with maximum five (5) jumps and the other with maximum three (3) jumps, including the connecting jumps.

In the programme Espoir, Cadet and Youth, when the combination of jumps is composed from jumps of one rotation, like rule say, you have to count, for the max limit of the category (9 in Youth, 8 in Cadet and 7 in Espoir), the FIRST and the LAST jump of the combination that AREN'T connecting jump.

Example 1: combination 1Lz+1Lo+1Lo+1Turen+1F, the 1Lz and the 1F will be counted for the max. limit Example 2: combination 1A+1Turen+1S+1Turen+1F, the 1A and the 1F will be counted for the max. limit

In all the categories, where we say that specific jumps can only be performed maximum three times and the second or third have to be in a combination, if isn't respected, like also written on WS book for J/S, the skater will receive a deduction of -0.3 point in A mark.
